4. Teaching

I conceived, developed and taught ten courses, a summer school, a self-organised student course and a student conference, which offered me practical teaching experience, provided me with a host of syllabuses I can quickly update and adapt, and gave me confidence that I can teach new subjects.

My first teaching experience was gained in a self-organised course on the "Anthropology of Consumption". Then I co-organised the 2004 Berlin graduate conference on representations of statehood and rituals of resistance in Berlin, in which 30 students from Warsaw and Berlin participated. Based on my own training in informal and formal qualitative (ethnographic) and in quantitative methods, plus participation in a three-semester project seminar on "Work in West Africa" that included a four-month ethnographic research excursion to Nigeria, I suggested to use for the first time in Europe the *ECRIS* method (a rapid ethnographic appraisal developed in 1997 by anthropologists Thomas Bierschenk and Jean-Pierre Olivier de Sardan for Central Africa). We published our results in a collective publication (see "publications").

I drew on this experience when in 2022 I convened, organised and chaired the 6th Baltic Summer School of Anthropology "Global-to-Local Food Chains: Food Sovereignty and Climate Change", in Cēsis, Latvia: 28 international students attended expert seminars on the nexus between climate crisis and food sovereignty, participated in small-group fieldwork with local actors along the food chain (scientists, producers, processors and traders), and presented their findings.

I have formally taught since 2013, when Shakira Bedoya Sanchez, Gustavo Rioja and I developed and developed the course "Anthropology and Critique" for the B.A. seminar in Social Anthropology at the Martin Luther University in Halle. I enjoy reading classics alongside contemporary authors to see if their work can be put in conversation (see the introduction to my 2024 monograph "The Politics of Relations"), and my main interest in this course lay in exploring the interdependencies between critical theory and anthropology since the twentieth century.

In 2017, I taught three courses, two of which drew on my recently finished PhD thesis. These were the two-week-long bloc seminar on contemporary "Ethnographies of South-Eastern Europe" in the M.A. in Anthropology program at Riga Stradins University; and the seminar "Care Work" in the B.A. in Sociology and Social Anthropology program at Bielefeld University. Interested in exploring economic anthropology and sociology, I also co-taught a two-week bloc seminar "Money and Values" at the M.A. in Sociology at University Frankfurt/Main, with qualitative sociologist Matthias Thiemann.

In the academic year 2018–19 I was visiting professor at the M.A. program in Sociology and Social Anthropology at the Central European University (CEU) Budapest. Building on my experiences from the 2013 seminar "Anthropology and Critique", and adapting course material I sourced at Budapest, I taught the core course "Key Issues in Social and Cultural Anthropology I", covering the difficult heritage of anthropology from the mid-1800s to ca. 1968. Also in 2018, I taught a four-hour intensive course on the Anthropology of the State – the syllabus being entirely developed by myself.

In 2019, I conceived, developed and taught "Economic Anthropology", a four-hour intensive research-led course based on my post-doctoral research; and I furthermore taught the M.A. thesis writing workshop, a course that allowed all my students to pass their exams with high homours.

Exploring multispecies anthropologies in times of the Anthropocene, in 2022 I co-taught the course Environmental Anthropology with the Amazonia-specialist Paride Bolletin, as a joint course of the M.A.s of Social Anthropology at Riga Stradins University and of Masaryk University Brno.

In October 2024, as a visiting researcher at the Social Anthropology Postgraduate Program at Sao Carlos University, Brazil, I offered the mini course: Infrastructures of Value – Understanding the Materialities of Capitalism in Food and Farming.

In spring 2025, I will teach a considerably re-worked and updated course on Contemporary Research in Economic Anthropology at the Charles University, Prague.

My project studies how contemporary pigs in Serbia navigate frictions between veterinarization, environmentalism, recreational hunting, African-Swine-Fever, and a globalising meat sector, which produces toxic ecologies on different scales. One focus is on the metabolic triangle between humans, pigs and plants. These research foci are embedded in an appreciation of the longue-durée when pigs have repeatedly shaped politics in Serbia: since the nation state emerged in the 19th century, they were a major commodity and provided considerable tax revenue. First extensively reared for export, they were held ever more intensively in confined spaces and their chances to live their porcine affordances restricted. Throughout, pigs strongly impacted on the Serbian state.

2019-22 Comparing Vital Capitals: An anthropological analysis of the global value chains of sea buckthorn and raspberries (1.1.1.2/VIAA/2/18/271, Agreement No. 9.-14.5/87), funded by the European Regional Development Fund (Brussels, BE), €130,000.

The research project was carried out in Serbia, Latvia, and East Germany, triangulating multi-local participant observation and expert interviews to follow the berry fruits from the plantations to the end-consumers. The study compared how rules, norms and desires are assembled, negotiated and aligned to ensure the quality, safety, and competitiveness of global commodities. It queried modernisation paradigms that operate on center-periphery models, by tracing how the main innovations in sustainable food chains may emanate from peripheral rural spaces inside and outside the EU, and their values translated and channelled by European Union centres.

6. Future Research Plans

My future research plan consists of both short term and longer term perspectives on research and publishing, fostering collaborations and writing applications for funding. I start with the short term goals.

First, until November 2024, I am FAPESP Visiting Researcher at the Federal University of São Carlos, Brazil in the Laboratório de Experimentações Etnográficas (LE-E), funded with €20,000. In the project 'Materialities of Value: Comparing grassroots economics in the Global South and East', I work together with my host Catarina Morawska Vianna on a comparative analysis of the political ecologies of the mangroves of Olinda, a shanty town in Pernambuco State, Brasil, and the Djerdap National Park on the banks of the Danube river in Serbia. Furthermore, we aim to compare subversive festive traditions in the Global South and East − on the one hand a street procession (*acorda povo*) celebrating St John the Baptist/Xango, which is led since Covid19 by a queer Afro-brazilan band, on the other the female-led "Cooking with Balls" festival that mocks the kitsch of commercial food festivals and male-dominated politics in Serbia by celebrating the culinary preparation of testicles. I plan is to write two joint publications and to lay the grounds for further collaboration and exchange.

Second, I have started to turn my study of the political-ecological transformations of (South)eastern Europe into a cumulative habilitation at Charles University Prague. In the introduction, and in conversation with critical human geography and sociology, I explore how I combine anthropologies of infrastructure with anthropologies of value to arrive at the new conceptual framework that I dubbed "infrastructures of value." I argue that the value of commodities does not derive only from what consumers want to pay for it, or the amount of abstract labour necessary for their production, but also on the infrastructures underlying the circulation and transformation of the things, ideas and people that become assembled to shape, or "qualify", a commodity. I analytically differentiate between infrastructures of transport, containment, communication, and legal-scientific evidencing, and add the cross-cutting perspective of people-as-infrastructure. Empirically, the ethnography was done in 18 months of fieldwork on the raspberry value chain in Serbia (since 2016); on the sea buckthorn value chains in Latvia and Germany (since 2019); and on pig rearing in Serbia, Macedonia, Bulgaria and Bosnia-Hercegovina (since 2022). I plan to rework this habilitation for publication with a renowned international academic publisher.

Third, in a longer-term perspective, I envisage to apply for a multi-person, multi-year research project with a major funding agency (e.g. an ERC consolidator grant) exploring more-than-human relationships. This project will follow the surprisingly diverse becomings of this humble shrub—sea buckthorn (*hypophae rhamnoides*)—across diverse political ecologies and environments. Across Europe and Asia, sea buckthorn is a fascinating shape shifter: a medical plant in folk- and bio-medical contexts (Ayurveda, wound healing, coronary disease and wellness); a pioneer in the fight against desertification and a sentinel species of climate crisis; a classic source of vitamin C and an apparently novel "super food" undergoing huge oscillations in investments in R&D and acreage, in e.g. Romania and Greece.
